**নিজস্ব সংবাদদাতা, মালদা, ২৩ এপ্রিল**– বাগানে আম কুড়োতে গিয়ে অপহাত হল দুই ছাত্র। রবিবার সকালে মালদার চাঁচোল থানার মালতিপুরে ব্লকপাড়া গ্রামে ঘটনাটি ঘটেছে। পুলিশ দ্রুত ব্যবস্থা নিচ্ছে না অভিযোগ তুলে ৮১ নম্বর জাতীয় সড়ক অবরোধ করে বিক্ষোভ দেখায় স্থানীয় বাসিন্দারা। খবর পেয়ে ঘটনাস্থলে চাঁচোল থানার পুলিশ গেলে তাদেরও এলাকাবাসীর ক্ষোভের মুখে পড়তে হয়। এরপর ব্যবস্থা নেওয়ার আশ্বাস দিলে অবরোধ উঠে। জানা গিয়েছে, রবিবার ছটির দিনে গ্রামের চার ছাত্র শঙ্কর মাঝি (১৩), দীপঙ্কর মাঝি (৬), তানবীর আলম (১৪) ও মহম্মদ সামিম (১১) গ্রামের পাশের আমবাগানে মাটিতে পড়ে থাকা আম কুড়োতে গেলে একটি গাড়ি করে গামছায় মুখ ঢাকা চার ব্যক্তি শঙ্কর ও তানবীরকে জোরপূর্বক গাড়িতে তুলে নিয়ে যায়। দীপঙ্কর ও সামিম কোনওরকমে সেখান থেকে পালিয়ে গ্রামে গিয়ে সমস্ত ঘটনা জানায়। দীপঙ্কর জানায় যে তাদের চারজনকেই ধরে নিয়ে যাওয়ার চেষ্টা হয়। প্রথমে তারা শঙ্করকে ধরে। তারা তিনজন পালানোর চেষ্টার সময় তানবীর পড়ে যাওয়ার অপহরণকারীদের হাতে ধরা পড়ে যায়। এদিকে ঘটনাটি জানাজানি হতেই গ্রামবাসীরা সমস্ত ঘটনা চাঁচোল থানায় জানায়। কিন্তু এক ঘন্টা পরও পুলিশ না যাওয়ায় প্রতিবাদে এলাকাবাসীরা ৮১ নম্বর জাতীয় সড়ক অবরোধ করে। ঘটনাস্থলে পুলিশ গেলে তাদেরকেও ক্ষোভের মুখে পড়তে হয়। পুলিশ সূত্রে জানা গিয়েছে, নিখোঁজ শিশুদের পরিবারের অভিযোগের ভিত্তিতে তদন্ত শুরু হয়েছে।

# এবার ছোট চা বাগানও ক্ষুদ্র সেচের আওতায়

নিজস্ব সংবাদদাতা, জলপাইগুড়ি, ২০ এপ্রিল— এবার বড় চা বাগানের পাশাপাশি ছোট বাগানকেও ক্ষদ্র সেচের আওতায় আনতে চলেছে রাজ্য সরকার। পাশাপাশি কাঁটাতারের ভিতরে থাকা জমিতেও যাতে সেচ পৌঁছয় সেই চেষ্টাও চলছে বলে জলসম্পদ উন্নয়নমন্ত্রী সৌমেন মহাপাত্র জানিয়েছেন। বৃহস্পতিবার ক্ষুদ্র সেচ প্রকল্পের কাজ খতিয়ে দেখতে জলপাইগুড়ি আসেন তিনি। কথা বলেন জেলা প্রশাসন ও দফতরের আধিকারিকদের সঙ্গে। জেলায় বিশ্বব্যাঙ্কের অর্থানুকুল্যে যেসব কাজ হচ্ছে তারও পর্যালোচনা করেন তিনি জলপাইগুড়ি জেলায় ১০০ কোটি টাকা ক্ষুদ্র সেচ প্রকল্পে বরান্দের কথা ঘোষণা করেন সৌমেনবাব। জানান, অপ্রয়োজনে জলের ব্যবহার বন্ধ। সেই সঙ্গে কম জলে যাতে প্রয়োজন মেটানো যায়, সে চেম্টাই চলছে। ইতিমধ্যে বড় চা বাগানে জলের অপচয় বন্ধ করতে স্প্রিংলার ইরিগেশন চালু করা হয়েছে। এই পদ্ধতিতে বৃষ্টির মতো জলধারা চা গাছের প্রয়োজনীয় জলের চাহিদা মিটিয়ে দিচ্ছে। ঠিক একই ব্যবস্থা এবার চালু করা হচ্ছে ছোট চা বাগানগুলিতেও। তিনি বলেন, বেশ কিছু বাগান ইতিমধ্যেই এই পদ্ধতিতে জলসেচ করছে। বাকি বাগানগুলিতেও এই ব্যবস্থা পৌঁছে দেওয়া হবে।

# গরুমারায় নিখোঁজ আরও একটি গভার

নিজস্ব সংবাদদাতা, জলপাইগুডি, ২৩ এপ্রিল— চোরা শিকারিদের হাতে জোডা গভার নিধনের পর গরুমারা জাতীয় উদ্যানে আরও একটি গভার নিখোঁজ। বনবিভাগ সূত্রে এখবর জানা গেছে। পরিবেশপ্রেমীদের অভিযোগ, নিখোঁজ গভারটিকেও হত্যা করে খড়গ কেটে নিয়ে পালিয়ে যেতে পারে শিকারিরা।

এর ফলে গরুমারায় বন কর্মীদের নজরদারিতে ব্যর্থতা আবারও প্রকাশ্যে এসেছে। রবিবার গরুমারা এলাকা ঘুরে দেখেন বনমন্ত্রী বিনয়কৃষ্ণ বর্মন। তিনি জানান, গরুমারা জাতীয় উদ্যানে মোট ৫০টি গন্ডার রয়েছে। এরমধ্যে দু'টি চোরা শিকারিরা মেরেছে আরও একটি গন্ডার বর্তমানে নিখোঁজ রয়েছে। সেটির খোঁজে গরুমারা জুড়ে তল্লাশি শুরু হয়েছে। তিনি জানান, নজরদারি জন্য গ রুমারার প্রতিটি গন্ডার পিছু একজন করে বনকর্মীকে দায়িত্ব দেওয়া হয়েছে। ডুয়ার্স সহ জলদাপাড়া ও বক্সা জঙ্গলেও নজরদারি বাড়ানো হয়েছে। জঙ্গলের অভ্যন্তরে তল্লাশি শুরু করেছে কর্মীরা। বিনয়বাবু বলেন, ইতিমধ্যে গরুমারার এক বিট অফিসারকে সাসপেভ করা হয়েছে এবং এক রেঞ্জারকে শো'কজ করা হয়েছে। এরপরও যদি দেখা যায়, গাফিলতি রয়েছে, তাহলে শক্ত হাতে তা মোকাবিলা করা হবে। পুলিশের সহযোগিতা নিয়ে গোটা ঘটনার তদন্ত হচ্ছে। এদিকে বনকর্মীদে একটি অংশের দাবি, পর্যাপ্ত কর্মীর অভাবে ধুঁকছে দফত। বহু বছর বন্ধ হয়ে গিয়েছে বনবিভাগে নিয়োগ। বর্তমানে বনবস্তি এলাকার মানুষদের কাজে নামানো হয়েছে। অস্থায়ী কর্মীদের দিয়ে বিশেষ কাজও করানো যায় না।

বনমন্ত্রী বলেন, সমস্ত সমস্যা মেটানোর প্রক্রিয়া শুরু হয়েছে। পাশাপাশি জঙ্গলের এই প্রাণী গুলিকেও রক্ষা কতে হবে। এভাবে বহু মূল্যবান প্রাণ নষ্ট হতে। থাকলে ঐতিহ্য ধরে রাখা যাবে না

# চিতা বাঘের চামড়া সহ ধৃত ২

# রোগীর আত্মীয়দের জল-বাতাসা বন্টনের অনুমতি না মেলার অভিযোগ

নিজম্ব সংবাদদাতা, বহরমপুর, ২৩ এপ্রিল— মূর্শিদাবাদ মেডিকেল কলেজ হাসপাতালে ভর্তি রোগীদের আত্মীয় এবং চিকিৎসা করাতে এসে টিকিটের লাইনে দাঁড়ানো মানুষদের মধ্যে জল, ছোলা, বাতাসা বন্টনের অনুমতি না মেলার অভিযোগ করলেন জেলা কংগ্রেস নেতৃত্ব। শনিবার এই ঘটনাকে কেন্দ্র করে দফায় দখায় চাঞ্চল্য ছড়ায় হাসপাতাল চত্বরে। শেষে হাসপাতালের বাইরে জলের জার রেখে বোতলে ভরে জল এনে রোগীদের খাওয়ানোর ব্যবস্থা করেন কংগ্রেস নেতৃত্ব। এমনটাই জানান প্রদেশ কংগ্রেস কমিটির মুখপাত্র জয়ন্ত দাস। তিনি বলেন, 'মুর্শিদাবাদ জেলা এবং জেলার বাইরে থেকে প্রতিদিন হাজার হাজার মানুষ মেডিকেল কলেজ হাসপাতালে চিকিৎসা করাতে আসেন। ঘন্টার পর ঘন্টা তারা টিকিটের লাইনে দাঁড়ান। অথচ এই গরমে তারা যে একটু জল খাবেন, সেই উপায়ও নেই। কারণ হাসপাতালের সমস্ত পানীয় জলের কল খারাপ। এটা জানার পরে তিনদিন আগে প্রদেশ কংগ্রেস সভাপতি তথা বহরমপরের সাংসদ মেডিকেল কলেজ হাসপাতাল পরিদর্শনে এলে রোগীর বাড়ির আত্মীয়রা এই অভিযোগ করেন। অধীর চৌধুরী সঙ্গে সঙ্গে ভাইস প্রিন্সিপালকে সমস্তটা জানান। তিনি দ্রুততার সঙ্গে পানীয় জলের ব্যবস্থার আশ্বাস দেন। কিন্তু তিনি তা না করায়, আজ বহরমপুর টাউন কংগ্রেসের পক্ষ থেকে হাসপাতালের টিকিট কাউন্টারের সামনে আমরা তৃষ্ণা নিবারণ অভিযাজ করি। ভাইস প্রিন্সিপলের কাছে এ ব্যাপারে অনুমতিও চাওয়া হয়। কিন্তু তিনি আমাদের সেই অনুমতি দেননি। তাই বাধ্য হয়ে আমাদের হাসপাতালের গেটের জলের জারগুলো রেখে এসে বোতলে বোতলে জল ভরে ভরে রোগীর আত্মীয়দের তা দিয়েছি। এর চেয়ে দর্ভাগ্য এবং লজ্জাজনক ঘটনা আর কি হতে পারে। আমাদের দাবি. অবিলম্বে পানীয় জলের কল এবং শৌচাগারের ব্যবস্থা হাসপাতাল কর্তৃপক্ষকে করতে হবে।" কংগ্রেসের এই অভিযোগের পরিপ্রেক্ষিতে যোগাযোগ করা হয় হাসপাতালের ভাইস প্রিন্সিপাল তথা সুপার ডা. সুহৃতা পালের সঙ্গে। তিনি এ নিয়ে কোনও কথা বলাতে রাজি হননি।

# উচ্চ প্রাথমিক ও হহিদ্ধলে শুরু শিক্ষক নিয়োগের তোড়জোড়

নিজম্ব সংবাদদাতা, বালুরঘাট, ২৩ এপ্রিল— প্রাথমিক শিক্ষক নিয়োগের কয়েক মাস পরেও উচ্চপ্রাথমিকে নিয়োগ সম্পন্ন করতে পারেনি রাজ্য সরকার। আদালতে ঝুলে থাকা বেশকিছু মামলা নিষ্পত্তি না হওয়ায় ১৫ মার্চের মধ্যে নিয়োগ প্রক্রিয়া শেষ করার কথা রাখতে পারেননি শিক্ষামন্ত্রী। এবার রায় হবার আগেই নিয়োগ প্রক্রিয়ার বেশকিছু কাজ এগিয়ে নিয়ে যেতে উদ্যোগী হলো রাজ্য শিক্ষা দফতর। যাতে রায় বের হতেই অতিদ্রুত শূন্যপদ পুরণ করা সম্ভব হয়। সূত্রের খবর, জেলার জনিয়র হাইস্কুল ও মাধ্যমিক পর্যায়ের স্কুলগুলিতে শিক্ষকে শূন্যপদ পূর্ণ করতে ছাত্রছাত্রীর অনুপাতে শিক্ষকের পরিমাণ জানতে চাওয়া হয়েছে। ইতিমধ্যে এই মর্মে স্কুল কর্তৃপক্ষকে নির্দেশও পাঠিয়েছেন। জেলা বিদ্যালয় পরিদর্শক (মাধ্যমিক)। এর মাধ্যমে জেলায় শিক্ষক নিয়োগ হলে শিক্ষা ব্যবস্থার মান উন্নয়নের পাশাপাশি বেশকিছু বন্ধ স্কুলও নতুন করে খুলতে পারে বলে মনে করছেন অনেকেই।

উল্লেখ্য, রাজ্যের অন্যান্য জেলার পাশাপাশি দক্ষিণ

দিনাজপুর জেলাতেও হইস্কুলগুলিতে দীর্ঘ বছর ধরে শিক্ষক নিয়োগ আটকে রয়েছে। শিক্ষকের অভাবে বন্ধ হয়ে রয়েছে বেশকিছু স্কুলও। কিছু কিছু স্কুলে প্রয়োজনীয় শিক্ষকের অভাবে পড়াশোনা ঠিকঠাক হচ্ছেনা বলেও অভিযোগ। অনেক ক্ষেত্রে একজন শিক্ষককেই বিদ্যালয়ের যাবতীয় কাজকর্ম করতে হচ্ছে। মিড'ডে মিলের বাজার সহ ছাত্রছাত্রীদের খাবার ব্যবস্থা, স্কুল সংক্রান্ত অফিসের কাজকর্ম সেরে আনুসাঙ্গিক কাজও করতে হয় তাঁদের এরপর ক্লাস নেওয়া তাঁদের পক্ষে অসম্ভব হয়ে ওঠেছে। এমন পরিস্থিতিতে রাজ্যের হস্তক্ষেপে স্কুলগুলিতে দ্রুত শিক্ষক নিয়োগ হলে পড়াশোনার পাশাপাশি স্কুলের চেহারাও বদলাবে অনেকাংশে বলে মনে করা হচ্ছে।

জেলা বিদ্যালয় পরিদর্শক (মাধ্যমিক) দীপঙ্কর রায় জানিয়েছেন, রাজ্যের নির্দেশে জেলার স্কুলগুলির শূন্যপদ ও পরিকাঠামোর বিষয়ে তথ্য সংগ্রহ চলছে। আগামী ২৫ তারিখের মধ্যে স্কুলগুলিকে নির্দিষ্ট তথ্য জমা করার নির্দেশ দেওয়া হয়েছে।
